Seniors Quartets may compete in both the Pioneer District Quartet Contest and the International Seniors Preliminary Contest but must designate either or both on the entry form.

NO LATE ENTRIES, QUARTET OR CHORUS, WILL BE PERMITTED.

If you are unable to enter the contest on-line, contact either Director of Contest and Judging Ron Eubank or District Secretary Joe Serwach and they will assist you. If you need help **DO NOT** wait until the last day. Ask for help in sufficient time to allow for a timely submission of your entry.
